It is in the best interest of the owners/applicant to complete the building work by obtaining a Certificate of Completion within the specified period. The specified period is 2 years. If the work is incomplete the owner or applicant has to make an application to the Permit Authority for an extension before a permit expires. The Building Surveyor is required to provide a report to the Permit Authority on the status of the work including inspections undertaken and support the extension of an additional period.

If the building work is not started within 12 months from the date of the building permit being issued the permit will lapse.
