This was somewhat disappointing as Local Government continues to provide not only the vast inventory of rural and regional roads but also the essential community services that our communities rely on for their sustainability, wellbeing and advancement.

While we are assured that current Federal / Local Government funding will be maintained at current quantum's, the possibility for more equity in Federal Local Government funding appears bleak.

We all understand the restricted financial capacity of the Federal Government at the present time due to major overruns in the Federal Budget such as border protection and the NBN rollout, coupled with massive write-downs in Federal taxation receipts. Unfortunately I believe that there will be an extended period of austerity while the Federal Government addresses the budget deficit problem and strives to fund initiatives such as the National Disability Insurance Scheme, and Education Reforms .

When all issues are taken into consideration it would appear that there will be little or no new financial commitments for infrastructure, which is so badly needed across all local councils.

Council will be meeting with the new Federal Member for Lyons, Eric Hutchinson MHR, and working closely with him to keep abreast of Council issues and seeking solutions and partnerships with the Federal Government to meet the challenges of today and tomorrow for the betterment of the communities of Southern Midlands.

I would also like to take this opportunity to thank the former member for Lyons, Dick Adams, for his contribution and support of the Southern Midlands Council. In particular Dick was instrumental in gaining \$1.2 million from the former Federal Labor Government to provide matching funding from the State Government to reconstruct the Callington Flour Mill in Oatlands. Dick also supported the many heritage grants that we were successful in applying for, especially the Old Supreme Court House and the Gaolers Residence.

The major project underway in Southern Midlands at the present time is the Midlands Irrigation Scheme. It is indeed exciting that this major project is well advanced with the expected completion date about the end of March next year.

The availability of much needed irrigation water will provide the catalyst for greater expansion of farming enterprises in the midlands with the benefits of increased employment opportunities and the potential for service industries to establish and further add to economic development in the Southern Midlands region.

A significant associated benefit will be the availability of a supplementary water supply for Lake Dulverton. This will maintain the lake as important recreational area as well as its role as a wildlife sanctuary.

Another very important irrigation project recently announced was the South East Irrigation Scheme that will provide irrigation water through the areas of Tea Tree, Rekuna and Campania in the Southern Midlands Council area. These combined irrigation schemes provide a very exciting future for agriculture within the Southern Midlands region especially considering that the poppy industry continues to be a very important cash crop for the Southern Midlands and the industry appears positive into the foreseeable future.

While on matters of agriculture and farming, I wish to comment on recent media publicity regarding vicious dog attacks upon stock generally and sheep in particular. Recent media reports and letters to the editor have reported criticism of Council in circumstances where dog owners have not been prosecuted for these destructive dog attacks. While I can assure everyone that Council officers respond to every report made by farmers or members of the community, subsequent investigations do not always result in the dog's owner being brought to justice due to difficulties in positively identifying the attacking dog in many instances.

In the case of a dog attack, a successful prosecution requires witnesses to the attack who can positively identify the offending dog or dogs. The history of local Councils taking legal action over dog attacks has a low success rate as the onus of proof in a court of law requires "beyond doubt" evidence. Addressing this issue, therefore, needs a 'whole of community' approach, and this needs to start with responsible dog ownership practices by all dog owners.

Recently, in New South Wales, we have witnessed yet again massive property loss and decimation of local communities by fierce bushfires. These fires are a timely reminder to all property owners to reduce and remove excessive vegetation that may exist in or around your property. Not only will this action assist in protecting your property and your animals it will also reduce the fire risk to your neighbours.

We are privileged to have such dedicated and resourceful local volunteer fire fighters who put themselves in harm's way to protect our homes and our animals – any assistance to make their life less dangerous would be most appreciated by our local volunteer fire fighters, including SES and police, who all combine in combatting dangerous fires in rural and regional areas.

Unfortunately I must conclude on a sad note. Former Councillor, DPIPWE Agriculture Officer, Uniting Church parish council member and dedicated community group member Graeme Raphael sadly passed away recently. Graeme was involved in so many community groups and activities and gave his unqualified support to all. His support and involvement with the local schools in Southern Midlands, especially in passing on his vast knowledge of his beloved beekeeping, was a great contribution to the community. The historic cottage at 'Maher's Point was also a particular labour of love for Graeme who volunteered many hours to its restoration. Graeme's passing is a great loss to our community. We will always remember Graeme with great affection and admiration for his gentlemanly and caring nature; he left a great legacy of community, church and historical worth for our benefit.

Most bushfires in Tasmania occur during relatively mild summer weather and are easily controlled by firefighters. However, bushfires that break out on very hot, dry and windy days can

spread rapidly and may be difficult or

impossible for fire fighters to control. These fires can burn large areas of forest and farmland, destroy homes and livestock, and sometimes kill and injure people.

A properly prepared home is more likely to survive a bushfire than one that hasn't been prepared, and the chances increase significantly if able-bodied people are there to protect your home.

Properly prepared and defended homes can provide a safe haven during almost all bushfires.

However, Tasmania Fire Service recommends that you should not plan to defend your home when the <u>fire danger rating</u> exceeds 50 (severe) in your area unless you have created a defendable space and ember-proofed your home. However, the safest option always is to leave before a fire threatens your home.

Tasmania Fire Service recommends that you should not plan to defend your home when the fire danger rating exceeds 75 (extreme) in your area unless your home has a defendable space and has been designed and built specifically to withstand a bushfire.

Tasmania Fire Service recommends that you should not plan to defend your home on days when the fire danger rating exceeds 100 (catastrophic) in your area, even if your home has a defendable space and has been designed and built specifically to withstand a bushfire. If you are not staying to defend your property, you should plan to leave early. Many people have died in bushfires because they have tried to relocate too late, and have been trapped and burnt in their cars or on foot. Fewer lives will be lost if people who choose to leave do so well before a bushfire threatens their home.

Wildflower Time

It's wildflower time in the Midlands and the native bushland in our municipality can become a dazzling display of unique wildflowers in a good season. In fact, the Midlands is recognised nationally for its diversity of native wildflowers.

Two sites that are worth visiting at this time of year are St James cemetery at Jericho, and the Tunbridge Nature Reserve, just east of the Tunbridge village.

St James Cemetery has one of the few remaining refuges of natural grassland and wildflowers in our landscape. This site contains at least four threatened plant species, notable of which is the lanky buttons (*Leptorhynchos elongatus*) which is listed as 'endangered' and found at just a handful of locations in Tasmania. A new interpretation panel at St James will help you to identify this



unique wildflower. The natural values of the Jericho site are maintained by the Jericho Heritage Centre, Southern Midlands Council and local volunteers.

Paterson's curse Description:

Paterson's curse is an erect annual herb/plant growing between 600-900mm tall. Develops a rosette with



stalked, slightly hairy leaves to 300mm long with strongly lateral veins. Sometimes single stemmed, but usually several much branched stems on which leaves are narrower and smaller. Stems are hairy and the flowers are trumpet shaped, 20-30 mm long usually blue/purple.

Paterson's curse is beginning to establish in the Southern Midlands, particularly in the Mangalore and Bagdad areas. There is still the chance to con-

trol it because there are only isolated infestations.

Spanish heath Description:

Spanish heath is a woody shrub that can grow to 2 metres in height. It has bright green, feathery leaves, and produces masses of bell-shaped pinkish-



white flowers over winter and spring. The flowers produce thousands of tiny seeds in spring and summer.

Spanish heath (Erica lusitanica) is a weed that continues to be an issue for landholders in the wider Levendale area.

Cumbungi

Patches of Cumbungi (*Typha latifolia*) have been noted in farm dams, waterways and lakes in the Southern Midlands. Cumbungi poses a serious threat because it has the potential to spread rapidly, cover entire water bodies and



impede stock access to clean drinking water. There have been reports of stock becoming seriously bogged when trying to access water, where Cumbungi has changed the environment around a dam water edge. The key distinguishing features of Cumbungi are the large dark brown seed heads and lighter coloured leaves.

BLESSING OF THE GRAVES

Within the Catholic Church November has always been a time when special prayers are said for deceased relatives and friends. This year on Sunday, 24th November, members of the community are invited to gather with parishioners at the Oatlands Cemetery at 2pm and the Tunnack Cemetery at 3.30pm for a short ceremony of prayer and blessing of the graves.

SHIPPING CONTAINERS

Do you have a shipping container on your property for which you have not obtained a permit?

Shipping containers are in effect a building and the Building Regulations require that you obtain a building permit from Council for shipping containers.

In all circumstances they will require building approval and may also require a Planning Permit.

- Building regulations ensure safety. If shipping containers are inadequately anchored to the ground they can be blown over or across the ground by high winds. If ventilation is not installed and no improvements are made to their door mechanisms there is the chance of accidental lock-in and suffocation.
- Planning regulations ensure new development fits with community expectations. Within towns and villages - and especially within our historic precincts - shipping containers may not be allowed or may be required to be 'dressed up' to make a better fit with local character, such as creating a pitched roof and cladding the walls in traditional corrugated-profile colorbond of an appropriate colour. In rural areas shipping containers may need to be painted an appropriate colour on publicly visible sites.

These approval processes also enable Council to ensure that shipping containers are not located over rights-of-way, service easements and other infrastructure or too close to property boundaries.

The temporary placement of shipping containers on building sites for the secure storage of building materials and equipment is allowable whilst a building permit is in place, and must be removed at the completion of the project. Even so, they should still be adequately anchored to the ground, be ventilated and measures put in place to prevent accidental lock-in.

Swimming Pool Fencing

Pool fencing is designed to save children's lives by preventing their access to pools. However, it is alarming to see that the majority of children under five years of age who drown in swimming pools, do so as a result of fencing that is not compliant with the legislation. In other words, pool fencing that is not working or not being used as designed is contributing to the number of children drowning. A four sided fence, that does not include any part of the home, has proven to be the safest.

You must, by law, have a four sided fence around ANY pool that can be filled with more than 300mm of water. This includes inflatable and portable swimming pools.

The maintenance of pool fencing is extremely important, even if you do not have young children living at your home. Children are most at risk of drowning within 6 months of moving into a new property with a swimming pool, or when visiting the home of a friend, family or neighbour with a pool.

Pool fencing is a legal requirement and pool owners should regularly check their swimming pool throughout the year, especially in the months leading up to summer. The Royal Life Saving Society has launched a new Home Pool Safety

campaign targeting anyone who has a backyard pool. It provides sound advice in the form of a checklist that alerts pool owners to potential dangers that they may not be aware of.
