MAYORS REPORT

It is again my pleasure to report and provide detail regarding a number of positive developments and advancements that have occurred

within the Southern Midlands Council area since the issue of Councils' last newsletter.

Firstly, in relation to the 2018/19 Rates and Charges, I am very pleased to advise that the

percentage increase in the General Rate has been set at 1.9%, this being below the actual Consumer Price Index (i.e. inflation) for the previous twelve-month period. This increase is identical to the previous year and is possible due to the continued sound financial performance of your Council. Whilst this increase in the General Rate is almost the lowest of all Councils in Tasmania, it has been necessary to impose additional increases in the standard Waste Management and Household Collection Service charges. This is due to substantial rises in the costs to Council to dispose of waste at landfill sites and the gate fees for the deposit of recyclables. The latter reflecting the impact of the Chinese decision to curtail their intake of plastics. Additional detail relating to the Rates and Charges is included in this

The Tasmanian Government has allocated \$2.5 million in the State's 2018/19 budget to upgrade the Midlands Multi-Purpose Health Centre at Oatlands. This wonderful facility caters for and provides services to all of the Southern

Midlands and adjoining regions. This much needed upgrade certainly recognises and values the dedicated and professional staff who work at the Centre. It is expected that the project will be underway by the end of this calendar year.

I am also pleased to report that the State Government has provided funding of \$75,000 towards a new small scale

Community Health Centre to be established in the former Kempton Primary School's principal's residence. This is most welcome news as the residents of Bagdad and Kempton will be able to access health services within the local area. Works are planned to commence following finalisation of approvals, and in the interim. Council is working with a number of

community representatives to identify and attract potential service providers.

In relation to the Oatlands Aquatic Centre, the appeal process through the Resource Management and Planning Appeals Tribunal has now been finalised. Council is now able to

proceed to the stage of preparing a detailed design and

specifications. This will enable the project to go to tender which we anticipate will be early in 2019. Subject to

satisfactory tender prices, on-site works will commence prior to the end of this financial year.

Over the past year, Council has invested significant funds as part of implementing a number of Streetscape Improvement

Plans. Projects included planting of trees through the township of Colebrook; development of the Memorial Avenue at Kempton and re-fencing of the Recreation Ground at Kempton. Other similar town projects have been the ongoing renewal of kerb and guttering at Tunbridge; extension of the footpath at Campania and enhancement of the playground at the Broadmarsh Hall. Capital

expenditure on Council's roads and bridges continues to be a priority, with road reconstruction and resealing being a major component of Council's budget. Roads recently upgraded include East Bagdad Road, Elderslie Road, Native Corport Road, Steper Road, Washing Corport

Native Corners Road, Stonor Road, Woodsdale Road and York Plains Road.

The 'Coal Valley subdivision' at Campania has seen a large increase in the number of new dwellings being built in that area. I wish to welcome all new homeowners to Campania and thank them for choosing to build their home and live in the Southern Midlands.

Council has planned another very comprehensive and intensive work plan for the ensuing year with our focus firmly on undertaking projects aimed at enhancing community facilities and lifestyle to which we can all enjoy and be proud of.

'FRIENDS OF CALLINGTON MILL'

The 'Friends of Callington Mill' was originally formed in 2002 to help promote and support plans by the Southern Midlands Council to rebuild the Callington Mill as a fully operational windmill. The Friends were very active in the early years and had in excess of 60 paid-up members. The members promoted the merits of reconstructing to a number of high profile politicians and individuals, and

certainly played a big part in achieving the overall aim of reconstructing the Callington Mill.

In winding up the Friends in April 2018, an amount of \$1,366.77 was remaining in its Bank Account. This amount has been gifted to the Southern Midlands Council on the proviso that the funds are used for the sole

purpose of assisting with maintenance works on the Mill and Mill sails. It is confirmed that the funds will be expended on a project involving replacement of the Callington Mill sail clothes (and associated timber components) which have deteriorated since completion of the reconstruction process back in 2010.

The Southern Midlands Council wish to formally acknowledge and record its sincere appreciation for the work that the members of 'Friends of Callington Mill' performed over many years, and the many hours of volunteer input that ultimately resulted in the full reconstruction of the magnificent Callington Mill as a fully operational windmill.



NEW ROADSIDE RECYCLING & WASTE COLLECTION SERVICE

Residents and businesses on the kerbside collection service are informed that Council will be implementing changes to the service in August this year. The changes will be a fortnightly collection service for all collections and the replacement of the current 140lt wheelie bin (for general waste) and the replacement of the 55lt crate (for recycling) with two (2) new 240lt wheelie bins.

All current bins and crates will be collected by Council and replaced with the new 240lt bins. For residents already on the fortnightly collection service, your current 240lt bin will also be replaced with a new 240lt bin.

Council will mail all households and businesses on the kerbside collection service with the new fortnightly collection times and the dates for replacing the existing bins and crates.

Council will commence the replacement of old crates and bins with new 240lt wheelie bins on the following dates - Please allow 1-2 days for Council to replace:

Council's waste contractor, Thorp Waste, will commence a <u>fortnightly collection service</u> for all ratepayers/ residents currently on the collection service after the bins and crates have been replaced. Both waste and recycling will be collected on the same day. The new fortnightly collection service will commence on the following dates - all bins must be out by 6am on the day.

MANAGEMENT OF TREES ON COUNCIL LAND POLICY

Council sought feedback on the draft 'Management of Trees on Council Land' policy during July and August. It is an extensive policy and is available on Council's website.

Council officers will now review and incorporate the public feedback into the next version of the policy for Council's consideration prior to formal adoption. The final version of the policy will be made available on Council's website.

Under normal circumstances there would be no price increase to allow for the new service, however, an increase of approximately 5% will be applied to the annual household collection service charge effective 1st July 2018. This is necessary to meet increased costs of recycling and landfill disposal. The increase in disposal costs are being experienced nationwide. The increased costs to recycling are due to the recent import restrictions and bans imposed by China's Green Sword Policy (China is the largest importer and processor of recyclables in the world).

General Manager's Roll

Local Government elections are scheduled to be held in October 2018. In order to have a vote in the Southern Midlands Council elections, you must be enrolled on either the State electoral roll at an address in the Southern Midlands or on the General Manager's roll for the Southern Midlands municipal area. ANGLICAN CHURCH COMMUNITY FORUMS

The intent of each forum was to focus on the nominated property and gain an understanding of the community's position.

This information will now form the basis of a submission to the Anglican Diocese which Council will coordinate on behalf of the community.

CHAUNCY VALE WILDLIFE SANCTUARY BAGDAD

A lot of work has been going on at Chauncy Vale Wildlife Sanctuary to upgrade visitor facilities, walking tracks and signage. Grant funds supplied through the Government's Community Infrastructure Fund and Southern Midlands Council have been utilised to upgrade the main visitor facility now dubbed 'the Grand Chauncellor'.



The 'Chauncellor' has BBQ facilities for day visitors and a cosy meeting room with kitchenette which may be booked out for meetings and gatherings for a small fee.

Track work and new signage has greatly improved access to Brown's Caves area and to Guvy's Lagoon:

As part of Chauncy Vale Management Committee's goal

to improve the environment, protect facilities and keep visitors safe, ongoing rehabilitation works are being conducted to stabilise eroding stream banks. The current caretaker is available to take groups through the Day Dawn Cottage Museum, former home of renowned author Nan



Chauncy. The Caretaker can also custom make programs for community groups and schools, a specialty being night wildlife interpretation walks.

The Chauncy Vale web site is currently being upgraded. Upcoming community programs will be posted once this is complete.

BROADMARSH/ELDERSLIE PROGRESS ASSOCIATION - NEW PLAYGROUND

Congratulations to the Broadmarsh/Elderslie Progress Association who were successful in securing a Tasmanian Community Infrastructure Fund grant of \$39,201 to erect a new playground at the Broadmarsh Hall.

Community members put in a huge effort to install the playground themselves including building a new platform so the playground can be accessed direct from the BBQ hut shelter. A rebound wall is also to be built on the tennis court to complete the project.



HYGIENE TIPS TO SAVE YOU TIME & MONEY:

WEED HYGIENE MATTERS - KNOW WHAT YOU'RE BUYING, KNOW WHERE IT COMES FROM!

Many of the weeds now established across the Southern Midlands came here as contaminants in imported grain (especially mainland feed wheat), hay, agricultural seed (eg ryegrass), birdseed, stock and/ or on machinery. Weed seeds also adhere to fleece, travel in mud on the hooves of livestock, on cultivating implements, on machinery tyres, in vehicle cabs, on shoes & clothing and/ or in firewood.

When you purchase anything new such as stock, feed &/ or machinery check where it comes from and what the weed risks are that may be present with your purchases. Washdown all purchased vehicles and machinery.

- \Rightarrow Thoroughly wash down newly purchased machinery prior to using it on your property
- ⇒ Purchase shorn sheep rather than long-wool sheep. If purchasing long-wool sheep consider shearing as soon as possible upon arrival at your property to minimise the weed spread risk
- ⇒ Hold newly purchased stock or stock returned from agistment and hand-feed in one paddock or a small localised area for 4 days. Remove stock, monitor weed growth and control prior to flowering/seeding
- ⇒ Know when your high-risk periods are and avoid mustering or handling during this time. Ensure all lane ways and holding areas are free of weed seeds.

Cutting Edge Technology for our priceless heritage

An exciting new project is underway to develop a smart-phone 'app' which will bring to life the rich history of the Southern Midlands. This project is part of a co-operative venture being developed by Southern Midlands Council in conjunction with Brighton Council, Derwent Valley Council and Clarence City Council, with additional funding from Destination Southern Tasmania. Although still in the testing phase, the new app allows users to see views from the past suspended in 'augmented reality' with the help of some very clever technology. Working with 'smart' devices, this means – at its simplest – users will be able to look through the camera screens on their device, and see historic images hovering in space where they once would have been. DOG **REGISTRATIONS &** MICROCHIPPING

Dog owners are required by law to register their dog with their local council and have their dog microchipped. Register your dog

Once a dog is six months old it must be registered by a person over 18 years of age. If a dog belongs to a child, the registration must be in the name of a parent or guardian.

The registration period is between 1 July and 30 June each year. If you haven't registered your dog, please register them now.

Failure to pay the registration fee means that your dog is not registered and you may be issued an infringement notice, it is your responsibility to renew your dog's registration.

Dog Registration forms can be downloaded from Councils website or available from the Oatlands or Kempton offices.

RATES & CHARGES – 2018/19

General Rate:

The Southern Midlands Council has adopted a 1.90% increase in the General Rate for the 2018/19 financial vear. This percentage increase is applied to the 'cents in the dollar' levied in 2017/18. The General Rate is

calculated based on each property's valuation and the These rates and charges are for the year commencing Assessed Annual Value (AAV). The AAV is the actual or 1st July, 2018 and ending 30th June 2019 and are payanotional rental value of the property determined by the ble by 4 equal instalments, the first payable 30 days after State's Valuer General. The AAV cannot be less than 4 percent of the capital value. A fresh valuation is undertaken every six years and in between the AAV is indexed January 2019 and the fourth by 4.30 p.m. on 29th March every two years.

Waste Management Charge:

The Waste Management Charge is levied upon all rateable land and relates to the costs associated with the management and operation of Council's Waste Transfer Stations.

A standard charge of \$158 has been set where a dwelling exists (\$144 in 2017/18), and a charge of \$52 for vacant properties (\$48 in 2017/18). Multiple charges are levied where there is more than one dwelling capable of being occupied.

The increase in the annual charge is largely attributable to the substantial increase in the cost per tonne levied at the landfill sites where the waste is disposed (i.e. 40% increase); and an increase of approximately 185% in the Interest: In addition to the penalty, interest under section gate fee per tonne for the deposit of recyclables.

Garbage Removal / Household Collection Charge:

This charge is only levied on properties where the service **Discount**: is provided. An annual charge of \$165 has been set for A discount of 1.7% will apply to all rates and charges the provision of a fortnightly garbage and recycling removal service.

SMC STRATEGIC PLAN

Fire Service Contribution:

The State Fire Service Contribution is collected on behalf of the State Government to contribute towards the funding of the State Fire Commission. It is applied based on various fire districts. This contribution is also based on the AAV of the property and is subject to a minimum amount of \$40.

Where a ratepayer elects to enter into an arrangement to pay the current rates and charges by monthly, fortnightly, or weekly instalments via one of the electronic payment options (including direct debit), then the instalment amounts will be calculated to settle the debt by 30th June 2019. Penalty and interest will not be applied on any of the 2018-19 rates and charges at the relevant date, provided that the instalment arrangements are adhered to. In the event of default, penalty and interest is to be calculated on the outstanding amounts.

Late Payments:

Penalty: A penalty of 5% applies to any rate or charge that is not paid on or before the date it falls due.

128 of the Local Government Act 1993 will be charged at the rate of 7.5% per annum.
