



### **MAYORS REPORT**

The last 12 months have witnessed extraordinarily dry conditions throughout the Southern Midlands. We have also seen bushfires that caused extensive damage to properties in the Pelham and Elderslie areas. The Southern Midlands Council has been lobbying for recognition of drought status by the Federal Government, however, we have so far been unsuccessful. Although, within Tasmania other local government areas, including Devonport, have met the rainfall deficiency

criteria and have been drought declared, so far Southern Midlands has not met these strict requirements. We are continuing to seek drought recognition and assistance for our affected communities.

The State and Federal Governments have a number of assistance packages available to drought affected farmers. In Tasmania the Rural Relief Fund has been established by the State Government. Grants of up to \$1500 are available for immediate help with direct household expenses through to farm business expenses. Further amounts of up to \$5000 may be available upon completion of an Action Plan developed in conjunction with a financial specialist. #### Looking after your yard...

Overgrown or unsightly properties can be both a nuisance and a danger to neighbours and the community. All residents have a responsibility to keep their properties neat and tidy and to improve the appearance of our community, remove harborage for vermin to breed and reduce health risks. Unsightly properties can occur when objects or materials that are brought onto or allowed to accumulate on any vacant land, residential or commercial property, seriously affecting the aesthetic of the property.

Materials generally classified as unsightly include discarded or disused machinery, second-hand materials and similar objects, as well as derelict vehicles, old whitegoods, building materials and household waste.

#### **Responsibilities of residents**

Keeping your yard free from overgrown vegetation and objects makes our communities more visually appealing for everyone - here are a few tips on good ways to keep order in your property:

Store goods out of sight in your garage and shed; ensure you put your rubbish out for collection each fortnight; store
objects and materials out of view and neatly stacked to ensure they do not harbour vermin; dispose of old vehicles &
machinery – some metal recyclers may collect and remove them free of charge; cut or slash your grass regularly;
grass on larger properties (over 10,000m2) is not expected to be maintained to the extent of a lawn in an urban area.

#### Tasmanian Irrigation SOUTH EAST INTEGRATION PROJECT

Tasmanian Irrigation is delighted to be working collaboratively with South East landowners to design, construct and deliver high-surety irrigation water as part of a two-stage approach.

An extremely well attended community meeting was held on the 2nd March 2020 to discuss this project and the potential for landowners to secure long-term, reliable irrigation water. This meeting provided updates on the Expression of Interest process and progress on the Project, as well as planning for the South East Interim Solution.

The South East Integration Project will provide additional irrigation water to existing and new irrigators, interconnect all three schemes and standardise the systems. Approximately one third of landowners are located in new areas such as Brighton, Broadmarsh, Elderslie, Gretna and Rosegarland. It is expected that construction on this longer-term project, subject to approvals and funding being secured, will take three to five years.

# Convict Archaeology in the Southern Midlands **Picton Road Station, Kempton**

During January 2020, the second successful archaeological field school was held at the Picton Road Station site near Kempton. The station, constructed around 1840, housed convict men during the construction of the road from Hobart to Launceston and was largely abandoned in the 1850s.

In partnership with the University of Tasmania, council staff assisted with the facilitation of a two-week excavation season which saw 19 students trained in archaeological practice and a successful exhibition at the Kempton Watch House. The excavations revealed areas of the site including the hospital, carpenter's shop, storehouse and solitary cells and built upon the findings of the 2019 season.



We are fortunate to have internationally renowned archaeologist Professor Eleanor Casella of UTas co-directing this project and that this important convict site can become part of wider archaeological stories about those who built the highway and experienced the convict system.

#### **UPDATE: Mobile Food Vans Survey**

As reported in the January Newsletter, Council are undertaking a survey to understand the views of the community regarding operation of mobile food

vendors/food vans in the Southern Midlands. The survey was requested by Councillors at the December Council meeting, when the idea of forming a policy position around mobile food vendors was raised.

Results so far ... At the time of writing, over 100 responses have been received. This is a fantastic result so thank you to everyone who has participated! I can report from the responses received to date:

- Around 95% of respondents are in support of mobile food vendors operating in the Southern Midlands;
- We have received responses from people all over the Southern Midlands;
- Most of the respondents are residents and/or local business owners;
- The number of responses from each age group is quite balanced: and
- The online survey has proved very popular, with the majority of responses received so far through this option.

#### **UPDATE:** Oatlands Aquatic Centre

Preliminary on-site works relating to the construction of the Aquatic Centre in Oatlands is about to commence. This follows an extensive & lengthy process of rehabilitation of the proposed site (i.e. previous Works Depot). Council & the Project Team surveyors have recently set out the building perimeter with excavation to commence shortly. Council will undertake the trimming of the existing sandstone to get the levels down to the reduced levels required for the pool so that the Tenderer does not have to consider excavation in sandstone for the Pool Hall as part of the Tender process. Numerous contractors across Tasmania & . Victoria have been screened and interviewed for several key trade packages.

A tender for the major component of pools and water treatment is due for imminent release while separately, the refined timber framing design for the building is similarly prepared for imminent tender. Council & the Project Team will incorporate the direct selection of these key trades into the overall Major Works Tender currently scheduled for the end of March 2020.

#### Public Open Space contributions for subdivisions

Providing & maintaining quality public open spaces for the community is an important role of Councils. Public open spaces include parks, reserves, gardens, sports/recreation fields and pedestrian or cycle paths and trails. When land is subdivided to create new lots suitable for housing it will increase the local population & therefore increase the demand for public open spaces in that area. As towns and cities grow it is necessary for Councils to provide for new public open spaces and make improvements to the existing ones for the benefit of the community.

In Tasmania, the Local Government (Building and Miscellaneous Provisions) Act 1993 (LGBMP Act) gives Councils the power to require a subdivision developer to contribute to the provision of public open space commensurate with the increase in public open space demand likely to be created by their subdivision. The LGBMP Act provides that Council may take up to 5% of the subdivision land area for public open space, or a cash in lieu payment equivalent to the value of 5% of the unimproved land value at the time of subdivision (or a combination of the two up to 5%).

New subdivision proposals are assessed to see if they are large enough or in an area where part of the land would be useful or desirable for a new park, pathway or the like. If there is no part of the land that is suitable for public open space and/or it is a small subdivision, then a cash in lieu payment will be required. Cash in lieu payments must be held by Council in a separate account and can only be used for improving existing public open spaces or purchasing land for public open space when needed. Improvements such as playground equipment, seating, barbecues, paths and trails can be funded from these contributions.

Southern Midlands Council direct these funds to the town/area from which they have been generated to ensure that the local community benefits from the growth in their area.
