Oatlands and the Southern Midlands received excellent promotion from the bullock team demonstration. It was a great spectacle and well done to everyone involved.

#### **MMPHC** and Oatlands Ambulance Operational Issues

Following the large attendance at the public meeting held last November at the Oatlands District High School, at which the State Minister for Health (the Hon Michael Ferguson MP) attended, considerable operational reviews have been initiated or undertaken in relation to the issues raised. The issues have been considered and addressed by both the MMPHC administration and senior officers of the Department of Health and Human Services (DHHS).

I am pleased to report that significant progress has been made, which has seen a considerable reduction in the amount of time that the local Ambulance has been off line. Since the public meeting, through discussions and negotiations with the MMPHC staff and Ambulance Volunteers, the availability of the ambulance has increased considerably from an average of 61% 'on-line' from January

to October 2014, to an average of 91% from November 2014 to 31<sup>st</sup> January 2015 – a very pleasing improvement. I wish to thank the staff of the MMPHC, the Ambulance Volunteers, and acknowledge the efforts of Ambulance Tasmania for their commitment to increasing the availability of the Oatlands ambulance and improving the service to our community.

I also wish to report (and acknowledge) that the Minister has taken a personal interest in these operational issues since his attendance at the public meeting. He has demonstrated his commitment by personally attending a further five meetings of the Community Advisory Committee at the MMPHC.

There are ongoing discussions regarding all issues and some will take a period to resolve. I will keep the community advised of progress through this Mayors report.

#### Vale - Former Deputy Mayor Mark Jones OAM

It is with great sadness and a tragic loss to the community that we have experienced the passing of the Deputy Mayor, Clr Mark Jones OAM. Mark was an inspiration to us all, being an unselfish, dedicated and hard-working member for the Southern Midlands Council; the community of Oatlands and

Mark's involvement with many organisations in the Southern Midlands, both sporting and community, endeared him to all, and in particular, those who had the benefit of working with him.

The Midlands Multi-Purpose Health Centre was a particular passion for Mark and he certainly contributed to the MMPHC in so many ways. Community fundraising for the Palliative Care Unit being a more recent example, a facility where he regrettably passed away.

Deputy Mayor Mark Jones OAM was a loyal and passionate Deputy and provided great assistance to me personally. I am proud to say we became close friends through our mutual interest in progressing the aspirations of the Southern Midlands community.

We all thank Mark for his outstanding contribution to our local community. What I believe to be one of the biggest funeral attendances was testament to the respect, admiration and appreciation the community held for him. He will be greatly missed not only by myself, fellow councillors and staff but by everyone that knew him.

#### **Council Amalgamations**

Recently the Minister for Planning and Local Government (the Hon Peter Gutwein MP) convened a meeting of all Tasmanian Mayors and General Managers to discuss the potential for voluntary council amalgamations within Tasmania.

Myself and the General Manager attended a meeting for Southern Councils in Hobart where the Minister sought

co-operation from Councils to begin a discussion regarding reducing the number of councils in Tasmania.

Already, the Southern Midlands Council together with Brighton, Sorell, Glamorgan Spring Bay and Tasman Councils have agreed to establish a 'Common Services Joint Venture'. This is aimed at formalising the current resource sharing arrangements which occur between those Councils, and the intent of the Joint Venture is to introduce a structure that can provide a firm

foundation and strategic basis for this to continue. Details of this Venture was presented to the Minister at the conclusion of the regional meeting.

The five participating Councils (at this stage) are firmly of the belief that resource sharing without amalgamations, will prove to be the most cost effective and efficient way of providing services to our communities.

History of previous amalgamations, both nationally and internationally, gives evidence that property rates DO NOT REDUCE with amalgamations and staff rationalisation can be achieved by resource sharing and retaining local governance (councils).

I must emphasise that the Minister repeated many times that the present State Government will not support forced amalgamations but reiterated that he and the government believe there should be fewer councils in Tasmania.

The five southern councils who have signed the Common Services Agreement will now undertake a cost benefit analysis to quantify the benefits to our ratepayers and the Minister of this model.

# Councillor Vacancy - Recount and Election of new Deputy Mayor

Following the tragic passing of former Deputy Mayor Mark Jones OAM, a casual vacancy was created within Council. The Tasmanian Electoral Commission was advised of this situation and proceeded to fill the casual vacancy in accordance with the process detailed in the *Local Government Act 1993*. This involved a recount of the former Deputy Mayors' votes received at the October 2014 election.

I am pleased to advise that Mr David Marshall was elected as the candidate to fill the casual vacancy through to the next election, scheduled for October 2018. Councillor Marshall attended his first Ordinary Council meeting in February held at Tunbridge.

Councillor Marshall has lived in the Southern Midlands municipal area for over 30 years. He worked as a farmhand at 'Rockville' York Plains for ten years and then for Hydro Tasmania for a further 22 years. David has now retired to a small farm near Campania where he lives with his wife Christine. We extend a very warm welcome to Councillor Marshall.

Council was also required to elect a new Deputy Mayor at the February Council meeting. Again this follows a process detailed in the *Local Government Act 1993*, and involves seeking nominations and the conduct of a secret ballot of all Councillors.



Two nominations were received and following the conduct of a ballot,
Councillor Alex Green was elected to the office of Deputy Mayor.

Congratulations to Councillor Green, our new Deputy Mayor.

This exhibition looks at the extraordinary back-stories of some of the characters who populated Oatlands in the mid nineteenth century, and the choices they made when it came to decorating their homes. ## Frequently Asked Question: When is a Building Permit Needed?

In most circumstances building work will require a permit from your local Council.

E.g.: Dwellings, Additions, Garages, Sheds, Farm Buildings, Carports, Structural Repairs and other building works.

It is in your interest to obtain a Building Permit.

If you wish to sell your property in the future, potential purchasers will discover if there are works that have been undertaken without a permit. This may well hinder the sale and could potentially invalidate a signed contract if not disclosed beforehand. On the other side; if you purchased a property with building works which were not appropriately approved, you inherit all the associated problems.

The fundamental reason why the law required building permits is to ensure buildings are safe, and that it can be proved they are safe.

#### Certain buildings and building work are exempt

These regulations, other than Part 1, Divisions 1 and 2 of Part 2, regulation 23 and Part 4, do not apply in relation to obtaining a building permit under section 60 of the Act in respect of the following:



#### (a) an outbuilding if -

- (i) it is the only building of its type on the site; and
- (ii) the total area does not exceed 9 square metres; and
- (iii) no side is longer than 3 metres; and
- (iv) no part is more than 2.4 metres above the ground;
- (b) a pergola, garden arch, trellis or frame if the structure -
  - (i) does not exceed 20 square metres in total area; and
  - (ii) is no more than 3 metres above the floor or ground; and
  - (iii) is not covered or is covered only by open-weave material which allows water through;
- (c) a swimming pool if -
  - (i) the maximum possible water surface area is not more than 9 square metres; and
  - (ii) the maximum possible water depth is not more than 300 millimetres:
- (d) a non-roofed windmill, a mast, antenna or flagpole if -
  - (i) it is not attached to a building and not more than 6 metres high; or
  - (ii) it is attached to a building and is not higher than 6 metres above the topmost point of attachment to the building; or
  - (iii) it is a dish antenna with a diameter of not more than 2 metres and the total area of the dish antenna attached to the supporting structure is not more than 4 square metres;
- (e) a fence or wall constructed of masonry or concrete if it is not higher than 1.2 metres;
- (f) a fence constructed of a material other than masonry or concrete if it is not higher than 2.1 metres:
- (g) a retaining wall if -
- (i) it retains a difference in ground levels of less than one metre; and
- (ii) it is situated more than 1.5 metres from a boundary or way;

- (h) a water tank if it has a capacity of less than 45 kilolitres;
- (i) a water tank stand if it is not higher than 1.2 metres;
- (j) a builder's site shed if it is being
  - used in connection with building work for which building permit is in force; or
  - (ii) stored in a location permitted by the building surveyor;
- (k) an explosives magazine, a tank containing dangerous goods or a gas installation if the Competent Authority, within the meaning of the <u>Dangerous Goods Act 1998</u>, controls how the magazine, tank or installation may be used;
- the repair or maintenance of an existing building if the work is done for maintenance purposes using similar materials, equipment, installations and components to those being replaced;
- (m) a non-habitable underground structure on a mining lease;
- (n) the installation of a stairway lift or platform lift in a Class 1a building;
- (o) a temporary structure that is -
  - (i) required to have a temporary occupancy permit; or
  - (ii) exempted under <u>regulation 38</u> from the requirement to have a temporary occupancy permit.

#### Thinking of being an 'Owner/Builder'?

Within the building permit process an owner/builder is an owner of a property that takes on the responsibilities of the builder. To be an owner/builder you need to meet certain criteria and understand both your obligations and restrictions.

Warning: It is an offence for any person other than an appropriately accredited builder or an owner builder to manage or carry out the work of a builder. Building work carried out or managed by an owner builder may be subject of an audit by the Director of Building Control. To find out the full facts about the requirements for Owner/Builders visit the website Steps to becoming an owner builder which includes information and guidelines that all intending Owner/Builders must read before applying for pre-registration.

# A Reminder to Clearly Display your Property Address

Rural properties can be difficult to locate. Many people have experienced the frustration of trying to find an unfamiliar property in a remote area. This frustration is also shared by emergency services, utilities and delivery services.

In an emergency, every second counts. Finding your home is critical in the event of a medical emergency or a bushfire. Without a clearly positioned rural address number, emergency services vehicles can easily miss an entrance or may not even know a dwelling exists on a property. A delay in emergency services could mean the difference between life and death.

What are the Benefits of a Clearly Displayed Rural Address? Rural addressing benefits a whole range of people and organisations including:

 Emergency Services (police, ambulance, fire brigade) by being able to locate your property in an emergency.

- ♦ Commercial business by improved delivery of goods and services.
- Australia Post for more efficient mail delivery.
- Installation of new services such as power, NBN and other telecommunications
- Friends and family. Visitors will be able to follow the sequential numbers along the road and know the distance to reach your property; and
- ♦ Above all, it benefits you!

#### What you have to do

Please ensure your road number is clearly visible to road users at all times. It must be located at the main entrance to your home from a public road. The number must be reflective so it can be seen at night time.

#### **Council awards Major Contracts**

At its February 2015 meeting Council formally approved two major contracts. One being the refurbishment of the Rotherwood Road Bridge, over the Jordan River at Lower Marshes and the other being for Sports Ground Lighting at the Oatlands Recreation Ground as well as the Campania Recreation Ground.

#### **Rotherwood Road Bridge**

The refurbishment of the Rotherwood Road Bridge is to be undertaken by Tas Marine Constructions Pty Ltd at a value of \$169,260.00 excluding GST. The works will comprise the replacement of the timber deck with precast reinforced concrete units, plus the replacement of the bearings between the abutments and the steel beams. Works are required to be completed before the end of June 2015. The construction program is currently being refined to accommodate specific issues and it is anticipated that the contract period will be in the order 10

weeks. Given Rotherwood Road is a no through road property owners on the western side of the Jordan River have already been contacted in order to provide preliminary advice about the bridge works. Further information about a firm construction timeline, nominating bridge outage days, along with alternative access details will be provided to property owners over the next few weeks. It would be appreciated if travel in and around the Rotherwood Road area over the next few months could be kept to a minimum by non-residents, that would be greatly appreciated.

#### **Sports Ground Lighting Oatlands and Campania Recreation Grounds**

Sport and recreation are important components of the lifestyle enjoyed by residents and visitors to the Southern Midlands, and the Council has sought to provide reasonable access to a range of facilities and services over the years. A business case was prepared, in recognition of Coun-

> cil's Southern Midlands Recreation Plan, which supports the continuing development of our two principal sporting/recreation grounds, the Oatlands Recreation Ground and the Campania Recreation Ground.

> The current sports lighting of the two grounds is inadequate and significant safety issues arise through that current inadequacy. In fact the existing lighting poles have been condemned and have had to be removed. Therefore new and improved lighting is required.

> The proposed sports lighting of the two grounds will elevate the venues to a greater height of player and spectator convenience as well as

increase the usage of the grounds through night events for both football and cricket. This all leads to greater participation and as a result the health and wellbeing of the Community will be enhanced.

The works will be undertaken by Tasmanian electrical contractors Stowe Australia Pty Ltd for the amount of \$458,550.00 excluding GST (for both grounds). A grant has also been applied for through the Department of Premier & Cabinet's, Community Sport & Recreation Tasmania for \$80,000 (max. allowable amount) to assist in offsetting some of the capital costs of the projects.

Public enquiries in respect of these works should be All going well, the works are scheduled to be completed by the 22<sup>nd</sup> April 2015. Given both grounds will effectively be construction sites, with trenches and light pole foundations exposed. It has been determined by Council that the grounds will be restricted for public use during the contract period. The assistance of the general public would be greatly appreciated in not accessing the grounds and observing all advisory signs during the contract period.
